- 3. The Bulk Supply Price is applicable for supply of power to the Distribution Utilities of Odisha by GRIDCO. The aforesaid Aggregate Revenue Requirement and Bulk Supply Price application for the financial year 2024-25 contains details regarding energy charges, demand charges, charges for over-drawl of energy, rebate and delayed payment surcharge etc.
- 4. The rates and charges proposed by GRIDCO are published herewith for the information of the general public.
- 5. (a) A summary of the proposal will be posted in the Commission's website after **08.01.2024** for general reference.
 - (b) Interested persons may inspect/peruse the relevant records pertaining to the matters enumerated in Para-1 above and take note thereof at the office mentioned at Para-2 above, during office hours on or before 16.01.2024 by making a plain paper application to the aforesaid authority.
- 6. The Volume-I of the aforesaid Bulk Supply Price application including Technical & Financial Formats shall be available to the interested persons from the office mentioned at Para-2 above, during office hours on or before **16.01.2024** on payment of the photocopying charges of Rs.100/- only.

- 7. Proposed Bulk Supply Price Schedule of GRIDCO for carrying out Bulk Supply Activity for the FY 2024-25

Bulk Supply Price:

The Bulk Supply Price (BSP) proposed by GRIDCO, is applicable for supply of power to the Distribution and Retail Supply Licensees in the State. The claim of total charges by GRIDCO shall be calculated by summation of following charges stated in Para (A) to (F) below as applicable:

A. Energy Charge:

GRIDCO proposes to recover its net Revenue Requirement of Rs.13,912.40 Crore through Energy Charge / BSP only from the DISCOMs towards sale of 36263.00 MU. The average BSP is proposed @ 383.66 P/U only for recovery of above proposed net Revenue Requirement.

B. Demand Charge:

The maximum permitted SMD is proposed to be revised from the existing allowable limit of 110 % to 105 % of the approved annual SMD. The Demand Charge @ Rs.250/KVA/Month is proposed to be levied from DISCOM Utilities on the excess SMD only when the actual SMD of a DISCOM in a month exceeds the permitted monthly SMD (105 % of the approved SMD). Further, Such Demand Charges shall not be adjusted at the end of the year even if the actual monthly SMD remains within the permitted monthly SMD in any other month(s) of the same financial year.

C. Overdrawal Charges:

The Charges for Overdrawal of Energy payable by DISCOM Utilities are presently billed on month-to-month basis (at the corresponding OERC approved applicable BSP in terms of the Judgment dated 07.05.2018 of the APTEL passed in Appeal No.55 of 2015, till intra-State DSM Regulations is pronounced by OERC and implemented in the State). GRIDCO propose that this practice may be continued till Deviation Settlement Mechanism (DSM) Regulation is pronounced. Further, GRIDCO requests the Commission to reduce the existing monthly drawl limit from 110 % to 105 % of the monthly approved SMD for the DISCOMs for recovery of charges on account of any excess drawl of energy during a month over the approved quantum.

D) Fuel and Power Purchase Adjustment Surcharge (FPPAS):

FPPAS is the increase in cost of power supplied to the Distribution Licensee(s), due to increase in fuel cost, fixed cost, year-end charges, transmission charges, etc. with respect to cost of power purchase approved by the Commission in the ARR of the respective financial year. Such Surcharge is to be computed and raised by GRIDCO, if actual cumulative average monthly power purchase cost per unit (Rs/kwh) exceeds 3% of the approved average Power Purchase Cost per unit (Rs/kWh) in the ARR order of the Commission for the corresponding year. GRIDCO shall raise the bill for FPPAS on the Distribution Licensee(s) in the nth month at a uniform rate and in any month shall not be more than Rs 0.20/kWh (20 paise /unit). The unrecovered FPPAS in any month shall be considered at the time of truing up.

E) Rebate:

GRIDCO has proposed that on payment of the current monthly bills, the Distribution and Retail Supply licensees (DISCOMs) shall be entitled to:

- A rebate of 1.5 %, in case the DISCOMs make payment within 5 working days of serving of the BSP invoice by GRIDCO.
- A rebate of 1%, in case DISCOMs make payment on any day after five (5) working days and within a period of twenty-five (25) days of serving of the BSP invoice by GRIDCO.
- No rebate, if the DISCOMs have not paid the current month's BSP dues in full within a period of 25 days of serving of the BSP invoice by GRIDCO.

F) Delayed Payment Surcharge:

For delayed payment of Bulk Power Supply Bills i.e., payment after the period of 30 days from the date of submission of bills, the surcharge is to be levied @ 1.50% per month.

G) Duty and Taxes:

The Electricity Duty levied by the Government of Odisha and any other statutory levy/ Duty/ Tax/ Cess / Toll etc. imposed under any law from time to time shall be charged over and above the Bulk Supply Price.
