The Govt. of Odisha have constituted an independent Regulatory Commission known as Odisha Electricity Regulatory Commission (OERC) with one Chairperson and two other Members under Odisha Electricity Reform Act, 1995 and the same continue as such as envisaged in the Electricity Act, 2003.

- One post of Chairperson of OERC will fall vacant with effect from 12.10.16.

Section 84 of Electricity Act, 2003, inter alia, states that the Chairperson / Member of the Commission shall be persons of ability, integrity and standing who have adequate knowledge and have shown capacity in dealing with problems relating to Engineering, Finance, Commerce, Economics, Law or Management. It has further been prescribed that the Member of the Commission shall not hold any other office.
- 6. As per the provisions in the Electricity Act, 2003 the Chairperson orthe Member shall hold office for a term of 5 years from the date he enters upon his office or till he/she attains the age of 65 years, whichever is earlier.

7. The Chairperson and Memberare entitled to get a pay of Rs.80,000(fixed) and Rs.77,765/-per month respectively. In addition, the Chairperson and Memberare further entitled to DA &
