- (iv) Preparation of Summary of issues raised by various objectors and replies by the licensees.
- (v) Writing of proposals by the licensees, objections raised by the objectors, rejoinders given by the licensees and reply to queries raised by Director (Tariff) in Order form. Submission of proposal, objections and rejoinders in Order form.
- (vi) The Consumer Counsel has to attend the public tariff hearings and SAC meeting.

The interested parties/ organizations may submit their Expression of Interest, experts, their qualification & experience in dealing such matters, past experiences, fees expected etc. with any other details they like to provide to the Commission for two consecutive years i.e. 2018-19 and 2019-20 latest by 15th September, 2017.
