In exercise of powers conferred under the relevant provisions of the Electricity Act, 2003, the Odisha Electricity Regulatory Commission has passed an order on 21.03.2016 in Case No.52 of 2015 with regard to determination of Aggregate Revenue Requirement and Generation Tariff for Odisha Hydro Power Corporation (OHPC) for FY 2016-17 effective from 01.04.2016.

The OHPC hereby notify the following Schedule of Generation Tariff for sale of power to GRIDCO Ltd. by OHPC with effect from 01.04.2016 which shall remain in force until further order of the Commission.
