Approval of its Annual Revenue Requirement and levy of Annual Fee and Operating Charges for SLDC Functions for FY 2008-09 filed by Orissa Power Transmission Corporation Ltd (OPTCL), before the Orissa Electricity Regulatory Commission, Bhubaneswar

- 1. Orissa Power Transmission Corporation Ltd (in short OPTCL), a deemed Transmission Licensee under Sec. 14 of the Electricity Act, 2003, on 30.11.2007 has submitted its Application to the Orissa Electricity Regulatory Commission for approval of its Revenue Requirement and levy of Annual Fee and Operating Charges for SLDC Functions for FY 2008-09, which has been registered as Case no. 63/2007. The application has been filed under Sections 32(3) & 181(2)(g) and all other applicable provisions of the Electricity Act, 2003 read with OERC (Terms and Conditions for Determination of Tariff) Regulations, 2004 and OERC (Conduct of Business) Regulations, 2004. The Commission has decided to take into consideration the aforesaid Revenue Requirement and levy of Annual Fee and Operating Charges for SLDC Functions for FY 2008-09 through a public hearing.

- 4. The proposed Revenue Requirement and levy of Annual Fee and Operating Charges for SLDC Functions for FY 2008-09 contains details regarding Annual Fee, Monthly Operating Charges, Scheduling and system Operation Charges and delayed payment surcharge.

The suggestions/objections should be filed in six copies and should carry full name and postal address of the persons/organizations/institutions sending the suggestions/objections and shall be supported by an affidavit. A copy of the said suggestion/objection shall be served on the undersigned. There shall be clear indication if the suggestions/objections are being filed on behalf of any organization/institution representing any category of consumers. It should also be specifically mentioned, if it is to be heard in person by the Commission. Suggestions/objections received after the date mentioned above or those which will prove deficient on any or more of the above points may not be taken into consideration by the Commission. It may also be noted that only those documents stating the suggestions/objections and filed through affidavit will be admitted for the hearing.
- 8. As directed by the Commission, the dates of hearing shall be duly published in the Newspapers and also communicated to the parties whose objections are admitted.

Scheduling and System operation charges

Scheduling and System operation charges of **Rs 3000 per day** or part there of shall be paid by the short term Customers.

Note:

- 1. The SLDC charges (Annual Fee &Operating Charges) shall be paid by the licensees using the Intra-State transmission system as may be specified by the State Commission.
- 2. The Annual Fee shall be paid by all the Users in advance in two equal installments, by 10th of April and by 10th of October of FY2008-09 respectively:

Provided that in case where the usage of Intra-State transmission system commences after the 10th of April **or** after the 10th October of a year, the fee for the period up to 30th September of the year and 31st March of the subsequent year respectively shall be required to be paid before the commencement of Intra-State transmission.

- 3. The Operating charges shall be paid monthly;
- 4. Besides the above Scheduling and System Operation Charges of Rs 3000 per day or part there of shall be paid by the short term Customers for each transaction or as decided earlier.
- 5. If the Fee and Charges as the case may be are not paid by the due date(s), surcharge at the rate of 1.25 percent per month shall be levied on the unpaid amounts:
- **6.** An amount equivalent to two months Operating Charges shall have to be deposited in advance through L.C by every User as security against default in payment of Operating Charges.
