#### **INVITATION OF BIDS FOR ARR & TARIFF EXERCISE FOR THE FY 2023-24**

The ARR and Tariff exercise for the FY 2023-24 to be conducted by OERC shall begin from 30.11.2022 and shall continue up to end of March, 2023. The ARR and Tariff applications for the purpose shall be received from the Generating Companies (OHPC & OPGC), Transmission Licensee (OPTCL), GRIDCO, SLDC and the four DISCOMs (TPCODL, TPNODL, TPSODL & TPWODL) for hearing and issuance of order.

Bids in two parts (Technical & Financial Bids) are invited from interested bidder to represent the interest of the consumers in the proceeding to be taken up by OERC as per Section 94 (3) of the Electricity Act, 2003. The bidder can be a reputed agency/organization/Consulting firm/Institution having experience in dealing with ARR and tariff matter. The selected bidder shall objectively analyze the tariff applications of the licensees and generators and present their findings in the hearing as well as in the SAC meeting including assisting the Commission in writing draft order.

#### Scope of work:

The detail scope of work is as below:-

- (i) Preparation of short summary & gist of all the ARR proposals with analysis to be submitted to OERC for posting in the OERC's website. The analysis shall include the impact of RPO, Cross subsidy & cross-subsidy surcharge on tariff, Suggestion for optimizing Power Purchase cost and Competitive Industrial tariff.
- (ii) Preparation of summary of issues raised by various objectors and replies by the licensees to be prepared prior to the date of hearing.
- (iii) Preparation of Presentation for Public Hearing, Composite presentation of facts and figures in Commission's Tariff Hearing & at SAC meeting for which dates will be intimated in due course.
- (iv) Preparation of Summary of issues raised by various objectors and replies by the licensees and generating companies.
- (v) Assisting the Commission in writing draft orders including proposals by the licensees & generators, objections raised by the objectors, rejoinders given by the licensees & generators and observation of the Commission.
- (vi) The Consumer Counsel has to attend the public tariff hearings and SAC meeting.
- (vii) Compare the Retail Supply Tariff of Odisha with other States.
- (viii) The above work shall start from 1<sup>st</sup> January and end by 31<sup>st</sup> March, 2023.
- (ix) The sealed Bidder shall visit the office of OERC as and when required during the engagement period.

#### **Eligibility Criteria of bidder and duration of assignment:**

The bidder for the work should have experience of successful completion of at least two (2) assignments relating ARR & tariff exercise for State Govt. agencies/Utilities/SERCs/CERC etc.

The interested bidder may submit their offer to the Commission latest by 28<sup>th</sup> November, 2022 5.30 PM as per Format given at Annexure-I & II along with the details of experts available with them including their qualification & experience in dealing with such matters and any other additional information. The bidder shall be selected basing on technocommercial evaluation considering their experience and price quoted for the above work. The assignment shall be completed by 31<sup>st</sup> March 2023. The bidder should provide self-attested copy of valid PAN number and Goods & Service Tax Identification Number (GSTIN).

#### **Application and Evaluation Criteria:**

The Formats of application are at Annexure-I and Annexure-II for giving details of assignment(s) completed/ under progress and net worth/ turnover of the bidder in last three (3) years.

The bidder is required to submit separate bids for Technical and Financial Offers. The technical bid & financial bid shall be duly sealed and submitted in separate envelope mentioning BID for ARR and Tariff Exercise of OERC for the FY 2022-23 on the top of the envelope.

For the selection of bidder, the evaluation of bids will be done giving weightage to Technical component (70%) and Financial component (30%).

#### Weightage for Technical Parameters:

Weightage for different technical parameters will be as follows:

Technical Parameters	Weightage
The bidder's relevant experience	50
The qualifications and experience of the key staffs	20
The quality of the plan and methodology proposed	30

Weightage for Financial parameters: Proposal/ bid with the lowest cost will be assigned a score of 100 and other proposals will be assigned scores with reference to the lowest bidder.

The total score will be obtained by adding weightage of the Technical and Financial scores.

The Commission reserves the right to reject all or any bid without assigning the reason thereof.
