**NOTIFICATION**

No.OERC-JD(EA)/233/04- The Commission had framed Orissa Electricity Regulatory Commission (Terms and Conditions for Open Access) Regulations, 2005 which were published in Orissa Gazette, Extraordinary, No.988 dtd.21.06.2005. The said regulations were laid before the Orissa Legislative Assembly which has approved the following amendments.

The Commission hereby notifies the said amendments for the information of the general public.

**Regulation 2(b):**

In Regulation 2(b), after the words “drawal allowed” and before the words “to a long-term customer” appearing in the second line, the words “after concurrence of Government” have been inserted,

**Regulation 10(4)&(5):**

- (i). The words “failing which the Licensees will be penalized” have been inserted at the end of sub-regulation (4) of Regulation 10.
- (ii). The words and figures “within 90 days” have been inserted at the end of sub-regulation (5) of Regulation 10.

**Regulation 12 (1)(a)(iii):**

- In sub-regulation (1)(a) (iii) of Regulation 12-
- (i). after the words “one lakh” and before the words “for transmission” appearing in the second line, the words “per MW” have been inserted;
  - (ii). after the words “fifty thousand” and before the words “for distribution access” appearing in the second line, the words and figures “per 500 KW” have been inserted.

OERC (Terms and Conditions for Open Access) Regulations,2005 was laid before the Orissa Legislative Assembly as per the requirement u/s 182 of the Electricity Act,2003.

The Orissa Legislative Assembly in its meeting held on 4<sup>th</sup> April,2006 has made some modifications/ amendments to the OERC(Terms and Conditions for Open Access) Regulations,2005. These modification/amendments are to be notified in the Gazette by the Commission and 310 copies of such Gazette notification are to be sent to the Dept. of Energy, Govt. of Orissa for laying before the Orissa Legislative Assembly in its coming session.

A draft copy of the proposed Gazette Notification is placed in the file for perusal and approval of the Commission.

On approval of the same, Secretary may take necessary steps for publication of the aforesaid amendments in Orissa Gazette and send the copies to Dept. of Energy, Govt. of Orissa for the aforesaid purpose.
