ADVERTISEMENT FOR THE POST
OF OMBUDSMAN (I&II) UNDER OERC

Applications are invited from suitable candidates for two posts of Ombudsman (I&II) under OERC, who shall settle the representations filed by the electricity consumers under Section 42(6) of the Electricity Act, 2003 for non-redressal of their grievances by the Grievance Redressal Forum(GRF) established by Distribution Licensees of the state. The detail terms & conditions of the appointment are as follows:

Qualification & Eligibility Criteria: The applicants must have Bachelors Degree and have at least 25 years of experience in Legal/ Engineering/ Economics/ Finance/ Industry/ Civil Service/ Consumer Affairs or he must be a person of eminence. Knowledge of reading and writing in Odia is essential. The candidates having experience in electricity sector will be preferred. The applicant should have excellent Oral & Communication skill.

Age: The age of the applicant for the above post shall be below 62 years as on 31.05.2023.

Tenure of Appointment: The Ombudsman shall be appointed for a period of three years or till he attains the age of 65 years whichever is earlier. The terms and conditions of appointment and function of the Ombudsman shall be regulated by OERC (Grievance Redressal Forum and Ombudsman) Regulations, 2004.

Emoluments: The Ombudsman shall get a consolidated remuneration of Rs.60,000/- pm. In case of a retired person, the remuneration shall be in addition to pension. Besides the above remuneration, Rs.12,000/- pm is payable towards House Rent in case Govt. accommodation is not made available or not availed during continuance as Ombudsman in case of retired employees.

Leave: The Ombudsman shall be allowed CL of 12 days and 20 days EL in a year. The same shall lapse at the end of the year.

Submission of applications: Application complete in all respect in prescribed format along with copies of testimonials and a recent passport size photograph must reach the Secretary, Odisha Electricity Regulatory Commission, Plot No.4, Chunokoli, Sailashree Vihar, Bhubaneswar-751021 on or before **31.05.2023**. Persons in service in Govt./PSU are required to apply through proper channel. The applications received after due date shall not be taken into consideration.
