GENERATION TARIFF EFFECTIVE FROM 1st APRIL, 2022

In exercise of powers conferred under Section 64(4) and other relevant provisions of the Electricity Act, 2003, the Odisha Electricity Regulatory Commission (OERC) has passed an order on 24.03.2022 in Case No. 104 of 2021 with regard to determination of Aggregate Revenue Requirement and Generation Tariff for Odisha Power Generation Corporation Ltd. (OPGC) for FY 2022-23 effective from 01.04.2022.

The OPGC hereby notify the following Schedule of Generation Tariff for sale of power to GRIDCO Ltd. by OPGC with effect from 01.04.2022 which shall remain in force until further order of the Commission.
