2. **Family Pension:**

In the event of death of the pensioner family pension shall be payable to **Smt. Kalpana Sahoo (DOB – 06-09-1965)**, wife of Sri B.K. Sahoo from the day following the date of death of the pensioner till death or remarriage of the family pensioner in the following manner:

Sl. No	Particulars of Condition	Family Pension Amount
1	Death of the pensioner before attaining 65 years of age	(a) Rs.23,340/- p.m. (Rupees twenty-three thousand three hundred forty only) till 07/10/2023 or 7 years from date of death, whichever is earlier. (b) Rs.18,426/- p.m. thereafter. (Rupees eighteen thousand four hundred twenty-six only) (30% of last emoluments but limited to pension authorized on retirement.)
2	Death of the pensioner after attaining 65 years of age	Rs.18,426/- p.m. (Rupees eighteen thousand four hundred twenty-six only) 30% of last emoluments but limited to pension authorized on retirement.

3. The TI (temporary increase) is admissible on the original pension amount and shall be paid along with pension/family pension as per rules.
4. The commuted portion of pension of **Rs.9,336/-** may be restored from **20/01/2028** i.e. after 15 years from the date of commutation.
5. The payment of the aforesaid amounts shall be made to the Savings Bank Accounts No. **054100101003104** in the Corporation Bank, Nayapalli, Bhubaneswar, deemed as the pension account of Sri B.K. Sahoo.
