2. The TI (temporary increase) is admissible on the monthly pension amount and shall be paid along with family pension as per rules.
3. The payment of the aforesaid amounts shall be made to the Savings Bank Account No. 520101249664237 in the Corporation Bank, PBB, Nayapalli (IFS Code - CORP0000541), Bhubaneswar, deemed as the pension account of Smt. Rajani Behera.

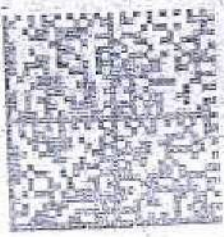
