2. **Family Pension:**

In the event of death of the pensioner family pension shall be payable to **Smt. Minati Swain (DOB – 02-06-1965)**, wife of Sri K. Biswal from the day following the date of death of the pensioner till death or remarriage of the family pensioner in the following manner:

2	Death of the pensioner after 7 years from the date of retirement	Rs.7,412/- p.m. (Rupees seven thousand four hundred twelve only) At Normal Rate

3. The TI (temporary increase) is admissible on the original pension amount and shall be paid along with pension/family pension as per rules, **if he has not been re-employed elsewhere.**
4. The commuted portion of pension of **Rs.2,471/-** may be restored from **01/02/2020** i.e. after 12 years from the date of commutation.
5. The payment of the aforesaid amounts shall be made to the Savings Bank Accounts No. **054100101000590** in the Corporation Bank, Nayapalli, Bhubaneswar, deemed as the pension account of Sri K. Biswal.
