### **GENERATION TARIFF EFFECTIVE FROM 1<sup>st</sup> APRIL, 2022**

In exercise of powers conferred under the relevant provisions of the Electricity Act, 2003, the Odisha Electricity Regulatory Commission has passed an order on 24.03.2022 in Case No. 103 of 2021 with regard to determination of Aggregate Revenue Requirement and Generation Tariff for Odisha Hydro Power Corporation (OHPC) for FY 2022-23 effective from 01.04.2022.

The OHPC hereby notify the following Schedule of Generation Tariff for sale of power to GRIDCO Ltd. by OHPC with effect from 01.04.2022 which shall remain in force until further order of the Commission.
