GENERATION TARIFF EFFECTIVE FROM 1st APRIL, 2025

In exercise of powers conferred under the relevant provisions of the Electricity Act, 2003, the Odisha Electricity Regulatory Commission has passed an order on 24.03.2025 in Case No.59 of 2024 for capitalization of the Capital maintenance work for replacement of main Inlet valve of all four Units of UIHEP & Case No. 83 of 2024 with regard to determination of Aggregate Revenue Requirement and Generation Tariff for Odisha Hydro Power Corporation (OHPC) for FY 2025-26 effective from 01.04.2025.

The OHPC shall hereby notify the following Schedule of Generation Tariff for sale of power to GRIDCO Ltd. with effect from 01.04.2025 which shall remain in force until further order of the Commission.
