GENERATION TARIFF EFFECTIVE FROM 1st APRIL, 2025

In exercise of powers conferred under Section 64(4) and other relevant provisions of the Electricity Act, 2003, the Odisha Electricity Regulatory Commission (OERC) has passed an order on 24.03.2025 in Case No. 82 of 2024 with regard to determination of Generation Tariff of Unit 1 & 2 for Odisha Power Generation Corporation Ltd. (OPGC) for the FY 2025-26 effective from 01.04.2025.

The OPGC hereby notify the following Schedule of Generation Tariff for sale of power to GRIDCO Ltd. by OPGC with effect from 01.04.2025 which shall remain in force until further order of the Commission.
