2 **Family Pension:**

In the event of death of the pensioner, family pension shall be payable to **Smt. Geeta Mohanty (DOB – 25-06-1970)**, wife of Sri Jyotish Chandra Mohanty from the day following the date of death of the pensioner till death or remarriage of the family pensioner in the following manner:

Sl. No	Particulars of Condition	Family Pension Amount
1	Death of the pensioner before attaining 65 years of age	(a) Rs.95,900/- p.m. (Rupees Ninety Five Thousand Nine Hundred only) till 30/05/2027 or 7 years from date of death of the pensioner, whichever is earlier. (b) Rs.57,540/- p.m. thereafter. (Rupees Fifty Seven Thousand Five Hundred Forty only) (30% of last emoluments but limited to pension authorized on retirement.)
2	Death of the pensioner after attaining 65 years of age	Rs.57,540/- p.m. (Rupees Fifty Seven Thousand Five Hundred Forty only) 30% of last emoluments but limited to pension authorized on retirement.

3. The TI (temporary increase) is admissible on the monthly pension amount before commutation and shall be paid along with pension/family pension as per rules.
4. The commuted portion of pension of **Rs.38,360/-** may be restored with effect from **01/06/2037** i.e. after 15 years from the date of commutation.
5. The payment of the aforesaid amounts shall be made to the Savings Bank Account No. **520101214222991** in the Union Bank of India, Nayapalli Branch, Bhubaneswar (IFS Code – **UBIN0905411**), deemed as the pension account of Sri Jyotish Chandra Mohanty.
