(c)	Commuted value of pension	Rs.89,046/- (Rupees eighty-nine thousand forty-six only)
(d)	Monthly pension after commutation	Rs.850/- p.m. (Rupees eight hundred fifty only)

2. **Family Pension:**

In the event of death of the pensioner family pension shall be payable to Smt. Sukanti Murmu (DOB - 11-07-1986), wife of Sri Ram Chandra Hansdah from the day following the date of death of the pensioner till death or remarriage of the family pensioner in the following manner:

1	Death of the pensioner within 7 years from the date of retirement	Rs.1275/- p.m. till 24/03/2016 (Rupees two thousand five hundred fifty only) At Enhanced rate (Twice the normal rate) limited to 50% of pay and subject to a minimum of Rs.1275/-
2	Death of the pensioner after 7 years from the date of retirement	Rs.1275/- p.m. w.e.f 25/03/2016 (Rupees one thousand two hundred seventy-five only) At Normal Rate i.e. 30% of last emoluments and subject to a minimum of Rs.1275/-

3. The TI (temporary increase) is admissible on the original pension amount and shall be paid along with pension/family pension as per rules, if he has not been re-employed elsewhere.
4. The commuted portion of pension of Rs.425/- may be restored from 25/03/2021 i.e. after 12 years from the date of commutation.
4. The payment of the aforesaid amounts shall be made to the Savings Bank Accounts No. 3776 in the Corporation Bank, Nayapalli, Bhubaneswar, deemed as the pension account of Sri Ram Chandra Hansdah.
