2. **Family Pension:**

3. The TI (temporary increase) is admissible on the original pension amount and shall be paid along with pension/family pension as per rules.
4. The commuted portion of pension of **Rs.10,446/-** may be reissued from **01/03/2024** i.e. after 15 years from the date of commutation.
4. The payment of the aforesaid amounts shall be made to the Savings Bank Accounts No. **CLSB-01-030010** in the Corporation Bank, Nayapalli, Bhubaneswar, deemed as the pension account of Sri S.N. Ghosh.
