No. SECY-SAC/CON/2010(Vol. IV)/616/ In exercise of the powers under Section 87(1) of the Electricity Act, 2003 read with Regulation 3 of the Orissa Electricity Regulatory Commission (State Advisory Committee) Regulations, 2004 and after consultation with the Govt. of Odisha, the Odisha Electricity Regulatory Commission hereby re-constitutes the State Advisory Committee (SAC) composed of the following members. The Chairperson of the Commission shall be the ex-officio Chairperson and two Members of the Commission shall be the ex-officio Members of the SAC. The Principal Secretary /Commissioner-cum-Secretary, Food Supplies and Consumer Welfare Department, Govt. of Odisha shall also be the ex-officio member of the SAC.

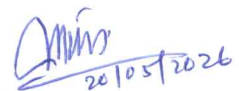

Extract of Section 87 & 88 of the Electricity Act, 2003

Section 87. (State Advisory Committee): --- (1) The State Commission may, by notification, establish with effect from such date as it may specify in such notification, a Committee to be known as the State Advisory Committee. (2) The State Advisory Committee shall consist of not more than twenty-one members to represent the interests of commerce, industry, transport, agriculture, labour, consumers, non-governmental organisations and academic and research bodies in the electricity sector. (3) The Chairperson of the State Commission shall be the ex-officio Chairperson of the State Advisory Committee and the Members of the State Commission and the Secretary to State Government in-charge of the Ministry or Department dealing with Consumer Affairs and Public Distribution System shall be the ex-officio Members of the Committee.

Section 88. (Objects of State Advisory Committee): The objects of the State Advisory Committee shall be to advise the Commission on –

- (i) major questions of policy;
- (ii) matters relating to quality, continuity and extent of service provided by the licensees;
- (iii) compliance by licensees with the conditions and requirements of their licence;
- (iv) protection of consumer interest; and
- (v) electricity supply and overall standards of performance by utilities.
