3. You are required to arrange for facilitating inspection/perusal and prompt supply of copies of Annual Revenue Requirement and Determination of Fees and Charges for SLDC Functions for FY 2026-27 during office hours at all offices mentioned in Para-2 above.

Interested persons may obtain a full set of the Annual Revenue Requirement and Determination of Fees and Charges for SLDC Functions for the Financial Year 2026-27 along with Truing up application for FY 2023-24 & FY 2024-25 during office hours between **18.12.2025 to 16.01.2026** from the Offices as mentioned in Para-2 above on payment of the photocopying charges of Rs.300/- only.
5. It may please be noted that you may file a consolidated rejoinder to all the suggestions/objections filed by the interested persons and admitted by the Commission on or before **27.01.2026** by serving a copy of the respective rejoinder to the person concerned.

**DETAILS OF PROPOSED LEVY AND COLLECTION OF FEES AND  
CHARGES FOR SLDC FUNCTIONS FOR FY 2026-27**

The annual charges for SLDC have been computed as per the provisions in the OERC (Fees & Charges of State Load Despatch Centre and other related matters) Regulations, 2010.

**(A) The details of Annual Charges which comprise of System Operation Charges (SOC) & Market Operation Charges (MOC) are given in the table below.**

*For the purpose of determination of the above charges for CGPs, the maximum MW scheduled during April to October 2025 has been considered*

*SLDC has proposed to levy and collect SLDC charges from the renewable projects, mainly Solar & Biomass having PPA with GRIDCO or wheeling for Captive purpose or generating for Renewable Energy Certification.*

**(B) Registration Fee: -**

*Besides the above charges, provision for collection of registration fee @ Rs1.00 lac from all users has been made as per OERC Regulation. It is also proposed to collect one-time registration fee from the industries who are importing power through Inter-State open access.*

**(C) Application Fee and Scheduling Charges: -**

*Application fee and Scheduling charges shall be paid by the open access customers as per the OERC (Terms and Conditions of Intra-State Open Access) Regulations, 2020.*
