Wanting information on Annual Revenue Requirement & levy of Annual Fees and Charges for SLDC functions filed by SLDC for FY 2025-26.

1. SLDC should furnish the details of month-wise receipt of Application Fee and Scheduling Charges from STOA customers for FY 2023-24 and FY 2024-25 (up to December 2024).
2. SLDC should furnish the details of month-wise receipt of Registration Fee from the users for FY 2023-24 and FY 2024-25 (up to December 2024).
3. SLDC should furnish the detail information regarding Month-wise and component wise (Basic Pay, DA, HRA etc.) actual employees cost for FY 2024-25 (up to December 2024).
4. SLDC may furnish the month-wise actual Cash flow Statement for FY 2023-24 and FY 2024-25 (up to December 2024). indicating the opening & closing cash balance.
5. SLDC may furnish the Annual Accounts for the 2023-24.
6. SLDC may furnish the year-wise details of available SLDC Funds & interest accrued and utilisation if any up to FY 2024-25 (till December 2024).
7. SLDC may furnish detailed Fixed Assets Register and CWIP position in the prescribed format as mentioned in para 83 of the SLDC Tariff order dated 13.02.2024 in Case No. 114/2023.
8. The details of Open Access allowed by SLDC may be furnished in a tabular form.
