- 3. The TI (temporary increase) is admissible on the monthly pension amount before commutation and shall be paid along with pension/family pension as per rules.
- 4. The commuted portion of pension of Rs.34,080/- may be restored with effect from 12/01/2037 i.e. after 15 years from the date of commutation.
