Sl. No.	Name of Existing/proposed Regulation	Regulation to be framed
1	OERC (Terms & conditions for Open Access) Regulations, 2005	Both the Regulations are to be merged and new Regulation is to be framed.
2	OERC (Determination of Open Access Charges) Regulations,2006	
3	OERC (Intra-State ABT) Regulations ,2008	This Regulation is to be repealed all together and new DSM Regulation is to be framed.
4	OERC (Terms and Conditions for Determination of Generation Tariff) Regulations ,2014	New Regulation for control period of 2019-24 is to be framed.
5	OERC (Forecasting, Scheduling and Dispatching of Renewable Sources) Regulations	New Regulation is to be framed or it can be merged in the DSM Regulation

For the above purpose the Commission intends to avail consultancy from reputed organisation. The Consultant shall assist the Commission for revision of the old Regulations and framing new Regulations. The Consultant may also be required to make study and submit report to the Commission regarding regulations followed in other SERCs/CERC. The Consultant should have the following qualification and experience.
