PUBLIC NOTICE

Dated, the _____ October, 2009

OERC vide its Order dtd. 20.03.2009 passed in Case No. 66, 67, 68 & 69 of 2008 (Retail Supply Tariff for 2009-10) has determined the tariff for Agro-Industrial consumer along with other categories. The Commission has stated in the said Order at Para 255 to bring about necessary amendment in the Regulation to clarify the matter. The Commission vide its Notification dtd. 19.10.2009 has brought necessary amendment to Regulation 80(5) of OERC Distribution (Condition of Supply) Code 2004 which has been published in Orissa Gazette No. 1586 (Extra Ordinary) dtd. 26.10.2009.

The Hon'ble High Court of Orissa in its Order dtd. 26.08.2009 passed in Case No. WP (C) 6516 of 2009 has directed the Commission to consider the feasibility of creating an additional tariff-category for agro-based industries applicable to non-agriculturist consumers and fix appropriate tariff for this category which seems to be the real intention of the Regulation 80(5). Hence, it has become necessary to fix tariff for those newly created categories.

Under the above circumstance Commission in exercise of power under Section 62 (4) of the Electricity Act, 2003 has fixed tariff as stipulated below for newly created categories.
