- 2. The bidder should undertake that no refurbished components will be used in the quoted products.
- 3. Bidder shall quote only those products in the bid which are not obsolete in the market and has at least 03 years residual market life i.e. the offered products shall not be declared end-of-life by the OEM before this period.
- 4. Bidder should provide original cartridge capacity, price and its life-span of the quoted MFP printer (Sl no.3).
- 5. Bidder has to quote detail price break-up as per format.
- 6. Rate quoted should be inclusive of all taxes and duties
- 7. The OEM of the item(s) should have at least of 01 no. of own service center at Bhubaneswar, Odisha to cater for aftersales service.
