Hearing of the common application filed by the M/s. GRIDCO Ltd. & TP DISCOMs of Odisha under Regulations 154, 199 & 204 of the OERC Distribution (Conditions of Supply) Regulations, 2019, seeking approval of Amnesty Arrear Clearance (AAC) Scheme for realization of long outstanding arrears other than Govt. consumers pertaining to pre-vesting period as on the respective effective dates i.e. arrears outstanding as on 31.05.2020 for CESU (now TPCODL), 31.12.2020 for SOUTHCO (now TPSODL) & WESCO (now TPWODL) and 31.03.2021 for NESCO (now TPNODL). M/s. GRIDCO Ltd. along with TP DISCOMs of Odisha have filed a common application before this Commission under Regulations 154, 199 & 204 of the OERC Distribution (Conditions of Supply) Regulations, 2019 seeking approval of Amnesty Arrear Clearance (AAC) Scheme for realization of long outstanding arrears of other than Govt. consumers pertaining to pre-vesting period as on the respective effective dates i.e. arrears outstanding as on 31.05.2020 for CESU (now TPCODL), 31.12.2020 for SOUTHCO (now TPSODL) & WESCO (now TPWODL), and 31.03.2021 for NESCO (now TPNODL).

The Commission has decided, vide its Interim order dated 23.06.2026, to dispose of this case through public hearing which shall be held on 04.08.2026 at 11.00 AM through hybrid mode. 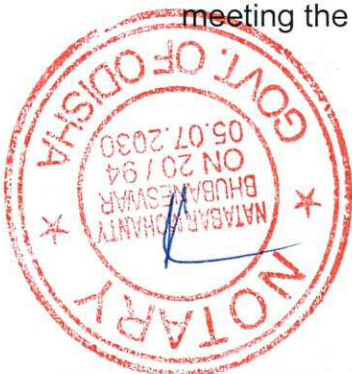

The Humble applicants above named respectfully sheweth:

1. **That GRIDCO Ltd.**, a company duly incorporated under the Companies Act, 1956 having its Registered office at Janpath, Bhubaneswar, Odisha, Pin-751022 being the State Designated Entity entrusted for ensuring energy security to the state by executing Power Purchase Agreements with the Developers for availing State share of power from various sources from inside and outside states and with onward supply of electricity in bulk to 4 Distribution Utilities in the State of Odisha and to make trading of surplus power after meeting the State demand.

utilities payable to GRIDCO towards settlement of old BSP dues. Accordingly, this petition is being jointly filed by GRIDCO and the four DISCOMs.

Background

I. OTS scheme 2009 by erstwhile DISCOMs:

The erstwhile Distribution Licensees namely WESCO (now TPWODL), NESCO (now TPNODL) and SOUTHCO (now TPSODL) had approached the Hon'ble Commission in the year 2009 for approval of OTS scheme for waiver of long outstanding dues pending with various categories of consumers. The Hon'ble Commission in its order dated 20.07.2011 in Case No.4, 5 & 6 of 2010 had approved the scheme. The scheme was valid for 120 days from the date of notification. Salient feature of the scheme were as under;

- a) Group A – All LT Category to whom DPS is not applicable: (a) 25% of the eligible amount if payment is made in 3 monthly installments within the scheme period i.e. 50% + 25% + 25% (b) 30% of the eligible amount as on 01/04/2011, if payment is made in 2 equal monthly installments within the scheme period i.e. 50% + 50% (c) 40% of the eligible amount as on 01/04/2011, if payment is made in full at a time within the scheme period i.e. 100%.
- b) Group B – All LT Category to whom DPS is applicable: (a) DPS in full + 15% of the eligible amount if payment is made in 3 monthly installments within the scheme period i.e. 50% + 25% + 25%. (b) DPS in full + 20% of the eligible amount, if payment is made in 2 equal monthly installments within the scheme period i.e. 50% + 50%. (c) DPS in full + 25% of the eligible amount, if payment is made in full at a time within the scheme period i.e. 100%
- c) Group C – All HT & EHT Category of consumers: (a) 40% of DPS of the eligible amount if payment is made in 3 monthly installments within the scheme period i.e. 50% + 25% + 25% (b) 50% of DPS of the eligible amount, if payment is made in 2 equal monthly installments within the scheme period i.e. 50% + 50% (c) Full waiver of DPS of the eligible amount, if payment is made in full at a time within the scheme period i.e. 100%

II. OTS Scheme 2022 by TP-DISCOMs

In the 2nd phase, the new DISCOMs namely TPCODL, TPWODL, TPNODL and TPSODL had approached Hon'ble OERC in the year 2022 for approval of OTS scheme-2022. The Hon'ble Commission in its order dated 22.12.2022 in Case No.122 of 2021 had approved the scheme. The salient features of OTS scheme-2022 are indicated below;

- I. Applicability – All categories of Consumers
- II. Applicability period – 120 days from the date notified by the DISCOMs based on the Hon'ble Commission's approval of the Scheme and it was further extended up to 31.07.2023 vide the Hon'ble Commission's order dated 23.05.2023 in the matter of Case no- 33/2023
- III. Eligible Amount – Arrears outstanding as on the respective Effective Dates i.e. Arrears outstanding as on 31.05.2020 for CESU (now TPCODL), 31.12.2020 for SOUTHCO (now TPSODL) & WESCO (now TPWODL) and 31.03.2021 for NESCO (now TPNODL).
- IV. Quantum of Rebate –
 - a) Group A - All LT Category of Consumers -
 - (i) 80% of Delayed Payment Surcharge (DPS) + 15% of the eligible amount, if arrear payment is made in three consecutive monthly instalments within the scheme period i.e. 50% +25%+25%.
 - (ii) 80% of DPS + 20% of the eligible amount, if arrear payment is made in two equal consecutive monthly instalments within the scheme period i.e. 50% +50%
 - (iii) 80% of DPS + 30 % of the eligible amount if payment is made in full at a time (i.e. in one instalment) within the scheme period.
 - b) Group B - All HT & EHT Category of Consumers -
 - (i) 40% of DPS, if payment is made in three consecutive monthly instalments within the scheme period i.e. 50%+25%+25%
 - (ii) 50% of DPS, if payment is made in two equal consecutive monthly Consumers instalments within the scheme period i.e. 50% + 50%.
 - (iii) 60% of DPS, if payment is made in full within scheme period in one instalment.

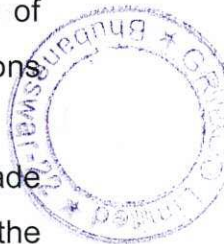
c) Other terms and conditions

- (i) The Consumer shall be entitled to either avail benefit under the OTS Scheme or opt for revision of bills. both options cannot be availed simultaneously i.e. if a consumer opts for revision of bills, he cannot avail the benefit under the OTS Scheme-2022.
- (ii) Electricity Duty (ED) levied on the respective Effective Dates of takeover of DISCOMs will remain unchanged and ED will not be waived even after waiver of dues under OTS Scheme. However, the OTS scheme for settlement of arrear ED pending against Captive Consumers for which Engineer-in-Chief(Electricity)- cum-Principal Chief Electrical Inspector, Odisha is the Nodal agency, shall be in line with the Government of Odisha Resolution No. 11797/En, Bhubaneswar dated 30.11.2022.
- (iii) Arrears under litigation can be settled through OTS Scheme-2022, if the concerned consumer withdraws the case pending in Courts, different judicial Forums, Ombudsman etc., and approach the concerned DISCOMs for availing benefit under OTS Scheme-2022. The OTS Scheme-2022 would also be applicable to consumers whose cases are under litigation in different Courts of law/ GRF / Ombudsman. In such cases, the consumers concerned shall submit an affidavit in prescribed format duly notarised by authorized Notary declaring that their application/appeal would be withdrawn from the relevant Court of law/Forum within validity period of OTS Scheme2022 to get the benefit of rebate.
- (iv) The DISCOMS shall be entitled to receive incentive on recovery of Arrears under the OTS Scheme as per the rates and conditions prescribed in the Vesting Order.
- (v) The DISCOMS shall maintain a separate account of realisation made against the Arrears under the OTS Scheme, which, after retaining the incentive as per the entitlement as mentioned above, shall be utilised by the DISCOMS as per provisions of the respective DISCOMS Vesting Orders.

III. Arrear Collection Target to TP-DISCOMs

Going forward, after vesting of Discoms, in the respective vesting orders, Hon'ble OERC stipulated for recovery of arrears of the pre-vesting period with recovery trajectory basing on the commitment of TPCL in its bid towards past arrear recovery. The same is given hereunder;

It is observed that the realization of arrears from pre-vesting dues is decreasing year by year because of the reasons like traceability of consumers, limited payment capacity of consumers, accumulating arrear amounts etc.

Although the operating TP-DISCOMs have surpassed their committed arrear collection targets as specified in the vesting order, the total arrear collection of Rs.1,977.05 crore (Gross arrear) achieved up to 30.09.2025 is not a significant amount when compared to the total outstanding dues of ₹8,014 crore, which is still reflected in the consumers' ledger balances as on 31.03.2025.

IV. Outstanding Arrear lying unrealized pertaining to pre-Vesting period

The total outstanding dues against other than Government consumers as on 31.03.2025 is Rs.8014.22 crore. The details are given in following table;

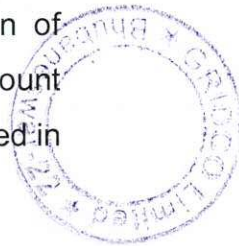

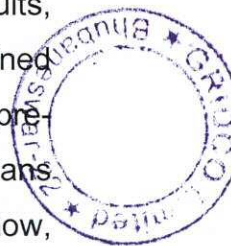
The OTS scheme-2022 could not yield adequate realization, due to constraints like, Consumer could either avail benefit under OTS scheme or opt for revision of bills under the Scheme. Both options were not available simultaneously. Therefore, consumers having outstanding with wrong billing didn't had a chance for availing the scheme benefits.

Outcome of the initial OTS scheme launched in 2010 was not very encouraging due to lack of public awareness and other operational challenges. Subsequently in the post-vesting period even though the OTS scheme-2021 was yielded certain results, but still substantial outstanding arrear pertaining to the pre-vesting period remained unsettled due to the aforesaid constraints. As the Residual Utilities, where such pre-vesting period outstanding arrears are parked, doesn't have any business or means to either collect or realize these arrears, the probability of arrear realization is very low, unless there is a separate mechanism is in place.

Accordingly, GRIDCO and the DISCOMs now propose to introduce an "Amnesty Arrear Clearance Scheme" for realization of arrears pertaining to the pre-vesting period.

V. Amnesty Arrear Clearance Scheme

The accumulation of long-pending electricity dues across different consumer categories has become a critical concern affecting the financial viability of the electricity sector. The outstanding arrears, compounded over time through the accrual of interest and penalties, have placed a significant burden on both consumers and the Discoms. This has adversely impacted the liquidity position and operational efficiency of the sector.

In several instances, consumers have sought to circumvent the recovery process by obtaining new service connections under alternate names or premises, thereby undermining the effectiveness of the existing recovery mechanism. Consequently, the overall arrear position continues to deteriorate, with post-vesting period dues also remaining unrecovered.

Comparable approaches have been successfully adopted in other sectors, such as the *Insolvency and Bankruptcy Code (IBC) mechanisms under NCLT, Non-Performing Asset (NPA) settlement frameworks in the banking sector, and Government Amnesty Schemes in taxation and compliance matters*, all of which aim to provide structured, time-bound relief and facilitate improved recovery.

Given Odisha's prevailing socio-economic conditions, including variations in consumer payment capacity and regional disparities, the introduction of an Amnesty Arrear Clearance Scheme is considered both appropriate and necessary. The scheme would provide consumers an opportunity to settle long-standing pre-vesting period dues in a transparent and equitable manner, while simultaneously enabling the Discoms to recover post-vesting period arrears which will result into

- I. Enhance overall revenue realization and cash flow;
- II. Reduce the burden of non-performing receivables;
- III. Improve consumer compliance and payment discipline; and
- IV. Restore financial stability and ensure the long-term sustainability of the electricity distribution sector.

Under the proposed scheme, the realized arrear amount would be beneficial for meeting past liabilities of erstwhile Utilities and in the process interest burden on GRIDCO will be reduced. Dues receivables from erstwhile DISCOMs/ Utilities as on

VI. Amnesty Arrear Clearance Scheme (Pre-Vesting Period) Proposal

- I. **Objectives of the Scheme:** This proposal seeks the approval for implementation of an **Amnesty Arrear Clearance Scheme** (Pre Vesting Period) aimed at addressing long-standing Electricity arrears owed by individuals, businesses, and institutions of Arrears outstanding as on the respective Effective Dates i.e. Arrears outstanding as on 31.05.2020 for CESU (now TPCODL), 31.12.2020 for SOUTHCO (now TPSODL) & WESCO (now TPWODL) and 31.03.2021 for NESCO (now TPNODL). The scheme is designed to recover pending dues while providing a fair and time-bound opportunity to consumers to regularize their accounts.

The Proposed salient features of Amnesty Arrear Clearance Scheme are indicated below:

- a. **Applicability:-** All categories of Non- Government Consumers
- b. **Applicability period** – 180 days from 01.04.2026 or date of approval whichever is later.
- c. **Eligible Amount** – The proposed **Amnesty Arrear Clearance Scheme** is only meant for settlement of the past arrears accumulated prior to the effective dates (i.e. pre-takeover) by present DISCOMs (TPCODL, TPWODL, TPNODL & TPSODL) and does not pertain to period after take over. Arrears outstanding as on the respective effective dates of takeover of DISCOMs i.e. arrears outstanding as on 31.05.2020 for Utilities: CESU (now TPCODL), 31.12.2020 for SOUTHCO (now TPSODL) & WESCO (now TPWODL) and 31.3.2021 for NESCO (now TPNODL) shall be considered as Eligible Amount.
- d. **Quantum of Rebate** – The OTS Scheme with the following rebate shall be applicable to different category or class of consumers:

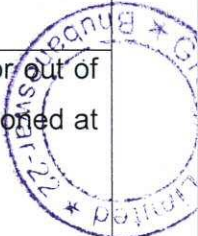

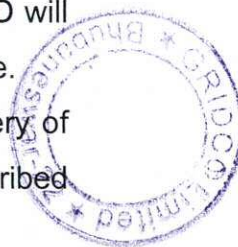


NB:

- 1) In case of consumers having outstanding due to wrong billing, the eligibility shall be determined after revision of such wrong bill and rebate as proposed under Category- A, B & C shall be computed.
- 2) Further, for all consumers, whose arrears are settled prior to notification of this Scheme under any mutual agreement and/or NCLT/NCALT/ any law/judicial/regulatory forum and payment terms/ instalments have been agreed/fixed, will not be covered under the present scheme.

III. Other terms and conditions

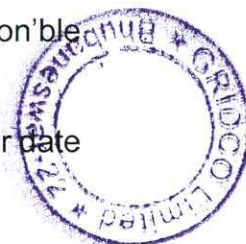
- (i) Consumers who have pre-vesting period outstanding, and such arrear is still continuing during the post-vesting period, shall be eligible to avail benefits of the Amnesty Arrear Clearance Scheme, to clear their outstanding dues pertaining to the pre-vesting period. Provided that, the consumer has to clear 100% Post vesting period dues, for availing benefit under this scheme.
- (ii) Adjustment of the amount realised from consumer under this scheme shall be adjusted as per the priority order set in para 152 of the OERC Distribution (Conditions of Supply) Code,2019.
- (iii) Consumers with wrong/ disputed bills, shall be eligible to opt for the Amnesty Arrear Clearance Scheme, after rectification of the wrong bills/ disputed bill irrespective of the period of outstanding of such wrong/ disputed bills.
- (iv) The corrected bill amount, once finalized by the competent authority, shall form the basis for calculating the scheme benefits. Upon revision of wrong/ disputed bills, corresponding ED shall be revised accordingly.
- (v) In cases, where no bill revision is required, Electricity Duty (ED) appearing in the consumer's account on the respective Effective Dates of takeover of DISCOMs, will remain unchanged and ED will not be waived-off even after waiver of dues under AAC Scheme.
- (vi) The DISCOMs shall be entitled to receive incentive on recovery of Arrears under the Scheme as per the rates and conditions prescribed in the respective Vesting Order(s).

- (vii) Consumers, whose electric connections are disconnected temporarily or permanently on or before the date of notification of the scheme can also avail the Scheme benefits, but for the pre-vesting period arrears only.
- (viii) The arrears under litigation can be settled through AAC Scheme, if the concerned consumer withdraws the case pending in Courts, different judicial Forums, ATE, Ombudsman, GRF, OERC, OHRC, OSCRF, District Consumer Forum, Appellate Authority or any other Forum etc., and approach the concerned DISCOM for availing benefits under this Scheme. In such cases, the consumers concerned shall submit an affidavit in prescribed format (to be provided by the concerned DISCOM) duly notarised by authorized Notary declaring that their application/appeal would be withdrawn from the relevant Court of law/ Forum within validity period of AAC Scheme to get the benefit of rebate.
- (ix) DISCOMs, after retaining the incentive as per their respective vesting orders, shall transfer the balance amount to GRIDCO towards settlement of old outstanding dues which were receivable from erstwhile distribution licensees. DISCOMs shall maintain a separate account for AAC Scheme, which shall be duly audited after the closure of the scheme. The audit details and amounts remitted to GRIDCO shall be submitted to the Hon'ble Commission.
- (x) After closure of the AAC Scheme-2026, DISCOMs shall submit the details of arrears collected from different category of consumers under this Scheme with type of consumers and the tariff category, DPS, eligible amount, age of arrears, outstanding amounts settled under AAC Scheme etc., within one month to the Hon'ble Commission.
- (xi) The scheme closure date shall be 180 days from 01.04.2026 or date of approval whichever is later.


