The detail terms & conditions of the appointment are as follows:

**Qualification & Eligibility Criteria:** The applicants must have Bachelors Degree and have at least 25 years of experience in Legal/ Engineering/ Economics/ Finance/ Industry/ Civil Service/ Consumer Affairs or he must be a person of eminence. Knowledge of reading and writing in Odia is essential. The candidates having experience in electricity sector will be preferred. The applicant should have excellent Oral & Communication skill.

Age: The age limit for the above post shall be between 52 to 62 years as on 01.04.2020.

**Tenure of Appointment:** The Ombudsman shall be appointed for a period of three years or till he attains the age of 65 years whichever is earlier.
