Sub: Publication of Applications u/S. 64(2) of the Electricity Act, 2003, read with Reg. 53(7) of the OERC (Conduct of Business) Regulations, 2004 for Aggregate Revenue Requirement and determination Wheeling Tariff & Retail Supply Tariff for the Financial Year 2018-19 filed by NESCO Utility before the Odisha Electricity Regulatory Commission, Bhubaneswar.

Sir,

With reference to your application dated **30.11.2017** before the Commission in respect of Aggregate Revenue Requirement and determination Wheeling Tariff & Retail Supply Tariff for the Financial Year 2018-19, which has been registered as **Case No.79/2017**, I am directed to say that the Commission has decided to dispose of the above application through a public hearing.

- 3) You are required to arrange for facilitating inspection/perusal and prompt supply of copies of the Aggregate Revenue Requirement and determination Wheeling Tariff & Retail Supply Tariff for the Financial Year **2018-19** as mentioned in Para (2) of the Public Notice.
- 4) Salient features of the Aggregate Revenue Requirement and Tariff Application along with other tariff related matters as mentioned in Para (1) of the Public Notice shall be made available to the interested person(s) from the offices mentioned at Para (2) of the enclosed notice on payment of the photocopying charges, **(Rs50/-)** on or before **16.01.2018**.

The said salient features as submitted by the licensee shall include:-

- i) write up on the application,
 - ii) calculation of expected revenue from existing and proposed tariff,
 - iii) information on subsidy,
 - iv) calculation of revenue requirement,
 - v) balance sheet
 - vi) profit & loss account.
- 5) Interested persons may obtain a full set of the Aggregate Revenue Requirement and determination Wheeling Tariff & Retail Supply Tariff for the Financial Year **2018-19** from your offices as mentioned at Para (2) of the enclosed notice on payment of the photocopying charges (Rs.200/-) during office hours on or before **16.01.2018**.
- 6) It may please be noted that you may file a consolidated rejoinder to all the suggestions/objections filed by the interested persons and admitted by the Commission, on or before **25.01.2018** with serving a copy of the respective rejoinder to the person concerned.
- 7) The proof of the above publications in English and Odia dailies shall be furnished to the Commission within seven days of such publications.

1. **NESCO Utility** has submitted its Application before the Odisha Electricity Regulatory Commission **on 30.11.2017** for approval of its **Aggregate Revenue Requirement and determination of Wheeling Tariff & Retail Supply Tariff for the Financial Year 2018-19**, which has been **registered as Case No.79/2017**. - (a) The suggestions/objections should be filed in seven copies and should carry full name and postal address of the person/ organizations/ institutions sending the suggestions/objections and shall be supported by an affidavit.
 - (b) There shall be clear indication if the suggestions/objections are being filed on behalf of any organization/institution representing any category of consumers. It should also be specifically mentioned if it is to be heard in person by the Commission.
 - (c) Suggestions/objections received after the date mentioned above or those which will prove deficient on any or more of the above points may not be admitted for hearing. Only those objections/suggestions supported through affidavit will be taken up for hearing.
7. As directed by the Commission, the date & place of public hearing shall be duly published in the news papers and also be communicated to the parties whose objections are admitted.
