**Sub: Publication of Application under Section 64(2) of the Electricity Act, 2003, read with Reg. 53(7) of the OERC (Conduct of Business) Regulations, 2004 for Aggregate Revenue Requirement and Determination of Wheeling Tariff & Retail Supply Tariff Application for the FY 2021-22 filed WESCO Utility before the Odisha Electricity Regulatory Commission, Bhubaneswar.**

Sir,

With reference to your application dated **01.12.2020** before the Commission in respect of Aggregate Revenue Requirement and determination Wheeling Tariff & Retail Supply Tariff for the Financial Year 2021-22, which has been registered as **Case No.75/2020**, I am directed to say that the Commission has decided to dispose of the above application through a public hearing.

- 2) In compliance with the provisions of Sec. 64 (2) of the Electricity Act 2003 and Regulation 53(7) of the OERC (Conduct of Business) Regulations, 2004, you are required to publish the matter as attached to this letter in English language in one issue each of a daily English and Odia newspaper and in Odia language in one issue of daily Odia newspaper, having wide circulation in your area of supply. The publication shall be made on or before **19.12.2020**. You are also required to put a copy of the said publication in the notice board of your office as well as in offices of all Engineers in charge of Distribution Divisions of your company and in your company's website.
- 3) You are required to arrange for facilitating inspection/perusal and prompt supply of copies of Aggregate Revenue Requirement and determination Wheeling Tariff & Retail Supply Tariff for the Financial Year 2021-22 as mentioned in Para (2) of the Public Notice.
- 4) Salient features of the Aggregate Revenue Requirement and determination Wheeling Tariff & Retail Supply Tariff for the Financial Year 2021-22 Application as mentioned in Para (1) of the Public Notice shall be made available to the interested persons from the offices mentioned at Para (2) of the enclosed notice on payment of the photocopying charges, **(Rs.50/-)** on or before **18.01.2021**.

The said salient features as submitted by the licensee shall include:-

- i) write up on the application,
- ii) calculation of expected revenue from existing and proposed tariff,
- iii) information on subsidy,
- iv) calculation of revenue requirement,
- v) balance sheet
- vi) profit & loss account.

- 5) Interested persons may obtain a full set of the Aggregate Revenue Requirement and determination Wheeling Tariff & Retail Supply Tariff for the Financial Year **2021-22** application from your offices as mentioned at Para (2) of the enclosed notice on payment of the photocopying charges, (Rs.200/-) during the office hours on or before **18.01.2021**.
- 6) It may please be noted that you may file a consolidated rejoinder to all the suggestions/objections filed by the interested persons and admitted by the Commission, on or before **29.01.2021** with serving a copy of the respective rejoinder to the person concerned.
- 7) The proof of the above publications in English and Odia dailies shall be furnished to the Commission within seven days of such publications.

**Publication of Application under Section 64(2) of the Electricity Act, 2003, read with Reg. 53(7) of the OERC (Conduct of Business) Regulations, 2004 for Approval of Aggregate Revenue Requirement and Determination of Wheeling Tariff & Retail Supply Tariff for the FY 2021-22 filed by WESCO Utility before the Odisha Electricity Regulatory Commission, Bhubaneswar-21.**

1. WESCO Utility has submitted its Application to the Odisha Electricity Regulatory Commission on **01.12.2020** for approval of its Aggregate Revenue Requirement and determination Wheeling Tariff & Retail Supply Tariff for the Financial Year 2021-2022, which has been registered as **Case No.75/2020**. The application has been filed under Section 62 and other applicable provisions of the Electricity Act, 2003 read with OERC (Terms and Conditions for Determination of Wheeling Tariff and Retail Supply Tariff) Regulations, 2014 and OERC (Conduct of Business) Regulations, 2004. The Commission has decided to dispose of the case through a public hearing.

A copy of the said suggestions/objections along with relevant documents shall also be served on the undersigned.
- (a) The suggestions/objections should be filed in seven copies and should carry full name and postal address with PIN Code alongwith E-mail ID and contact Telephone Number of the person/ organizations/ institutions sending the suggestions/objections and shall be supported by an affidavit.
  - (b) There shall be clear indication if the suggestions/objections are being filed on behalf of any organization/institution representing any category of consumers. It should also be specifically mentioned if it is to be heard in person by the Commission.
  - (c) Suggestions/objections received after the date mentioned above or those which will prove deficient on any or more of the above points may not be admitted for hearing. Only those objections/suggestions supported through affidavit will be taken up for hearing.
7. The date & place of public hearing shall be duly published in the news papers and also be communicated to the parties whose objections are admitted.
