Sub: - Invitation of applications for the post of Member, Odisha Electricity Regulatory Commission (OERC).

Sir/Madam,

The Govt. of Odisha have constituted an independent Regulatory Commission known as Odisha Electricity Regulatory Commission (OERC) with one Chairperson and two other members under Odisha Electricity Reform Act, 1995 and the same continue as such as envisaged in the Electricity Act, 2003.

- 2. One post of member of OERC will fall vacant with effect from 07.04.2014. For filling up of the post, Govt. have constituted a Selection Committee under section 85(1) of the Electricity Act, 2003.
- 3. Section 84 of Electricity Act, 2003 inter alia states that the member of the Commission shall be a person of ability, integrity and standing who have adequate knowledge of, and have shown capacity in dealing with problems relating to Engineering, Finance, Commerce, Economics, Law or Management. It has further been prescribed that the member of the Commission shall not hold any other office.
- 4. Keeping in view of the qualification prescribed in section 84 of the Electricity Act, 2003, Govt. have decided to invite applications from the Electrical Engineers having wide experience in generation, transmission, distribution or supply of electricity.

5. As per the provisions in the Electricity Act, 2003 the member shall hold office for a term of 5 years from the date he enters upon his office or till he/she attains the age of 65 years which ever is earlier.

6. The member is entitled to get a pay of Rs.77,765/-Per month. In addition the member is further entitled to DA & other allowances as admissible to the member of the Commission as per the Odisha Electricity Regulatory Commission (conditions of service of Chairperson and Members) Rules, 1997 and amendments there on from time to time.

7. Therefore the application alongwith other relevant information in plain paper as mentioned below are invited from suitable persons so as to reach the Commissioner-cum-Secretary to Govt., Energy Deptt., Govt. of Odisha with-in one month of the issue of this letter.
