In exercise of the powers conferred under section 39,40 and 42 of the Electricity Act, 2003 read with the provisions of Chapter II (Charges for Open Access) of OERC (Determination of Open Access Charges) Regulations, 2006, The Odisha Electricity Regulatory Commission has passed an order on 30.09.2014 in Case Nos.16, 17, 18 & 23 of 2014 with regard to approval of Open Access Charges (Transmission/wheeling Charges, Surcharge and Additional Surcharge applicable to open access customers for use of Intra-state transmission/ distribution system) effective from date of issue of order.

- 2. The wheeling and cross-subsidy surcharge as determined by the Commission for FY 2012-13 shall continue up to 31.03.2014.
- 3. The wheeling charge and surcharge as indicated in Table below shall be applicable w.e.f. 01.04.2014 retrospectively for the year 2014-15.

- 7. 20% wheeling charge is payable by the consumer drawing power from Renewable source excluding Co-generation & Bio mass power plant.
