GENERATION TARIFF EFFECTIVE FROM 1ST APRIL, 2013

In exercise of powers conferred under the relevant provisions of the Electricity Act, 2003, the Odisha Electricity Regulatory Commission has passed an order on 20.03.2013 in Case No.100 of 2012 with regard to determination of ARR and Generation Tariff for Odisha Hydro Power Corporation (OHPC) for FY 2013-14 effective from 01.04.2013.

The OHPC hereby publishes the Generation Tariff as applicable with effect from 01.04.2013 and shall remain in force until further order of the Commission.

The Generation Tariff applicable for sale of power to GRIDCO by OHPC, as approved by the Commission, in its order dt.20.03.2013 for the FY 2013-14 shall be as per the Schedule given below:
