In exercise of powers conferred under Section 64(4) and other relevant provisions of the Electricity Act, 2003, the Odisha Electricity Regulatory Commission (OERC) has passed an order on **21.03.2016** in Case No.53 of 2015 with regard to determination of Generation Tariff for Odisha Power Generation Corporation Ltd.(OPGC) for FY 2016-17 effective from 01.04.2016.

The OPGC Ltd. hereby notify the following Schedule of Generation Tariff for sale of power to GRIDCO Ltd. by OPGC Ltd. with effect from 01.04.2016 which shall remain in force until further order of the Commission.
