1. In this case Appeal in Form-D was sent by the appellant on 12.10.2017, which was received in the OERC office on 20.10.2017. In his appeal, the appellant has stated that he has filed this appeal since no reply was received from PIO, OERC in regard to his application dt.18.07.2017.
2. Vide notice No. 1493 dt.21.10.2017, the appellant was directed to appear before the First Appellate Authority, OERC on 02.11.2017 at 11.00 AM personally or through the authorized representative. In the same notice, PIO, OERC was directed to reply to the appeal petition on or before 25.10.2017 with copy to the appellant.
3. PIO, OERC has filed his reply to the First Appellate Authority, OERC vide his letter No.1496 dt. 23.10.2017 with copy to the appellant.
4. The case is heard today. PIO, OERC is present and Sri Jogendra Panda, the Appellant is absent.
5. The matter is heard ex-parte.
6. In his reply, PIO, OERC has stated that he had received the RTI application from the appellant on 20.07.2017. Since the application was incomplete due to submission of outdated IPO, PIO had written to the appellant vide letter No.1084 dt.20.07.2017 to furnish fresh IPO of Rs.10/-. The same letter sent by Regd. Post was returned back to OERC with postal remark "Not Known". PIO has, therefore, intimated that the appellant may be requested to furnish the valid IPO so that PIO shall make the necessary reply to the RTI queries.
7. The appellant is accordingly directed to furnish a valid IPO to the PIO. Thereafter PIO shall send his reply to the appellant within the stipulated time period.
8. The matter is accordingly disposed of.
