## THE HUMBLE PETITIONER MOST RESPECTFULLY SHEWETH:

In accordance with Section 23 of the Electricity Act, 2003 Hon'ble Commission vide their Order dated 14.01.2010 in Case No.01/2010 directed all concerned to implement power regulation in the state from 15.01.10 citing several factors responsible for the situation, primarily because there was a short fall of around 2000MU from hydro generating stations as per estimated availability for 2009-10. to the Senior General Mana

POWER SYSTEM In this connection Director (Commercial) intimated all DISCOMs and SGM (PS) to implement the order or (copy enclosed for reference as Annexure-A/1 to A/6).

> There were several meetings taken with DISCOMs. One by Director (Commercial) on 18.02.10 and the other by CMD GRIDCO/ OPTCL on 23.02.10 and again on 04.03.10 with DISCOMs and Industrial Associations like CII/UCCI

> The list of participants and record notes of discussion are enclosed herewith as

Annexure-B/1 to B/3.





- 6 In this context the following points are agreed which is placed before the Hon'ble Commission for consideration:
  - To implement an uniform regulation of 25% of power on the average consumption of all the HT and EHT industries;
  - To levy Rs.4/- (four) per unit for additional consumption over and above the consumption figure as per para (a) above subject to the condition that power is available;
  - c) Those industries likely to get power from outside having dedicated feeders can do so. They can avail such power through open Access (OA)/ Power Exchange which GRIDCO/ OPTCL/SLDC will assist.
- 7 Hon'ble Commission in para 23(3) of the order directed to install UFRs in graded frequency at 49.2Hz, 49.4HZ and 49.5Hz in the outgoing feeders of 132/33kV Grid S/S of OPTCL. After installation of UFRs frequent tripping of feeders are observed in NESCO and CESU area causing chaotic situation.

However, DISCOMs are to remain within their schedule in general and definitely when the frequency remains at 49.5Hz or below.

You are requested to furnish the availability of power every day to the DISCOMs. DISCOMs are to remain within their schedule especially when frequency falls below 49.5.Hz as per the provision of the Grid Code. When frequency falls below 49.2 Hz, you are requested to take immediate necessary measures to curtail the load in order to avoid overdrawl from E.R. grid as per mandate of the IEGC and also to avoid payment of penalty. OPTCL is also implementating UFR as per the order of Hon'ble Commission at clause.23 (3). As per clause.23 (9) of the order of Hon'ble Commission in case No1/2010 Dated 14.01.10, OPTCL/ SLDC should not resort to hand tripping of the feeders supplying power to the consumers but can do so if the concerned industrial consumers do not comply with the instructions of SLDC after giving adequate notice to them.

Please refer the above cited letter on implementation of the Order of the Hon'ble Commission dated 14.01.2010 for regulation of power in the State U/s 23 of Electricity Act' 2003.

No Compliance has been received so far from any of the Discom's. As per the order of the Hon'ble Commission, due care to supply power in night hours for the ensuing exams for 10<sup>th</sup> & 12<sup>th</sup> Board may be taken but implementing L/R during day hours and night offpeak hours as per availability of power and as per SLDC instruction should be implemented and compliance made thereof should be available to OERC, Gridco, OPTCL & SLDC.

As per the said order, there should be regulation of power to industries @ 25 % for HT and 15 % for EHT consumers. You are requested to raise the bills accordingly which has clearly brought out at Para-23 (4) of the order. Further those industries who have indicated to avail power to avoid L/R they should be billed as per Para-23 and the additional amount after 2 % service charge should be passed on to Gridco.

Enclosed please find herewith the list of feeders identified by CESU for installation of numerical backup relays for which necessary arrangement for releasing the relays may be made by CGM (O&M). The relays are to be installed as per Para-23 (3) without any further delay and the DISCOM's who have yet to submit the list of feeders for installing UFRs are requested to furnish the same immediately to CGM (O&M), OPTCL who will expedite release of the same to install in the feeders for ensuring the limit of drawal during low frequency regime for which ERLDC is pressing hard.

You are also requested to take up the matter for staggering of peak-demand with different industries locally and if possible off-days should be staggered in such a manner so that the peak-demand will be reduced. Further, DISCOM's should take up with consumers for their awareness of using Energy efficient lamps as mentioned at Para-22 and 23 of the order.

# Record Notes of discussion of the meeting held with the Industrial Association on implementation of order of OERC dated 14.01.2010 on Power Regulation

Members present are at Annexure.

A meeting was convened on 04.03.2010 at Gridco/ OPTCL conference hall with the representatives of Industries through Confederation of Indian Industries (CII) & Utkal Chamber of Commerce & Industries (UCCI) wherein DISCOMs, SLDC, OPTCL/ Gridco were present to discuss the implementation of power regulation in the State as per the order of OERC dated 14.01.2010 in Case No.01/2010.

Director (Commercial), Gridco welcomed all the delegates present during meeting.

SLDC detailed about the availability & demand of the state. There is availability of 48 MU while the requirement of the state is around 62 MU per day. The net short fall is about 14 MU per day.

CMD, Gridco/OPTCL expressed the need to implement the order of OERC dated 14.01.2010 and also abide Govt. instructions. He explained the provisions of the OERC order and Government instructions. The quantum specified above is based on assumption of availability, which may vary as per actual.

Coming to the regulation of power to the Industries, he sought the co-operation from them and proposed the following options for the industries having dedicated feeder at 33 kV level and above; for regulation of 25 % power as per actual consumption of the last 3 months.

<u>Option – 1:</u> Load shedding for 3 hours in the morning peak hour and 3 hours in the evening hours OR continuously for six hours preferably during evening peak hour.

<u>Option – 2:</u> 25% reduction of their average power drawal during the months of October, 2009, November, 2009 and December, 2009 on round the clock basis.

 $\frac{\text{Option} - 3:}{\text{availability.}}$  Availing power through open access with their own arrangement subject to

<u>Option -4</u>: Industries desirous of availing power above their entitlement as per the power regulation with 25% reduction; can avail it by paying additional cost as per the following with 10 paise per unit margin to Gridco.

- (a) Actual cost of power purchase, or
- (b) Rs.4.00 extra above the tariff applicable at the time of drawal

The above options will be filed before OERC for consideration and approval.

Mr V.K. Sood, Managing Director, WESCO, NESCO & Director, SOUTHCO suggested that combination of the options may be adopted for better implementation. He emphasized on constant co-ordination by Gridco/OPTCL/SLDC with the DISCOMs.

Mr S.P. Nanda of CII emphasized on self regulation to reduce 25% by industries on energy consumption (MU basis) and proposed to allow Open Access to the industries without payment of any surcharge. He also agreed for the additional payment which should be indicated in advance and to the extent acceptable by industries for drawal of power beyond the regulated quantum..

Mr M.V. Rao representing UCCI explained the difficulty of total outage for 3 hours/6 hours for continuous process industries. He explained that the contract demand is having a bearing on billing & explained that there should be proper co-ordination by all concerned.

After a lot of deliberation on the issues discussed above, the following issues were decided -

- → DISCOMs to intimate Municipalities, NACs on disconnection of power supply to hoardings during night hours and to take up the matter on closing of commercial markets by 08.30 PM as per the order of Hon'ble Commission.
- → DISCOMs to declare separate power holidays (1 day/week) staggered on different days in thirty districts separately.
- No regulation of power to emergency services like Railways, Water Supply, Important Hospitals etc.
- → DISCOMs to implement OERC orders and Govt. of Orissa orders
- → DISCOMs to adhere to day ahead schedule
- → For industries in Non –dedicated feeders, DISCOMs will effect load shedding at 33/11 kV on rotation basis as per requirement. Any drawal above 75% of their actual consumption of last 3 months will be charged at Re.1.00 per unit extra in addition to the normal tariff.
- → For Dedicated feeders Option 1/2/3/4 may be explored. Industries to send their views/requirements to DISCOMs within one week.
- Director (Commercial), Gridco will co-ordinate to implement the GoO/OERC orders.
- Director (Commercial), Gridco to file petitions before the OERC in this regard.

RECORD NOTES OF DISCUSSION ON 23.02.10 IN THE CONFERENCE HALL OF OPTCL REGARDING REVIEW OF POWER REGULATION AND IMPEMENTATION INTRA-ABT IN THE STATE.

Members present: As per list enclosed as Annexure.

- Initiating the discussion Director (Commercial) welcomed the members and appraised them the salient features of the OERC Order dated 14.01.10 on Power Regulation.
- CMD GRIDCO/OPTCL welcomed all participants and emphasized on the discussion of intra-ABT besides implementation of OERC Order on power regulation at length. CMD informed that several meetings have been held in Govt. and OERC where power regulation in the state has been dicussed. In this context there are two issues involved. On one hand to carry out the OERC Order and in other hand to moderate this order as per the direction of Chief Minister. He pointed out that we in the power sector should have a balanced approach without blaming each other. In case one if unit of OPGC trips and a unit of TSTPS Kaniha goes out of bus bar then in such a contingency SLDC has to act and consequent upon which the crisis was managed We in the power sector facing similar problems and co-ordinated effort by all concerned is required, i.e. Govt., OERC, GRIDCO, OPTCL and DISCOMs to mitigate the situation. There is power shortage which may continue for one or two more years with implementation of Ragiv Gandhi Gramin Vidyut Yojna (RGGVY), Biju Gram Jyoti Yojna (BGJY) and rapid industrialization in the state and the demand for power is going up. If generation comes in time perhaps we may tide over the situation. He further emphasized respective CEOs may monitor load regulation as per OERC order with due care to maintain un-interrupted power supply to railways, water works and major hospitals and in case of any difficulties may be in touch with Director(Commercial), Director(Engineering) and SLDC.
- On behalf of Reliance Managed DISCOMs, Mr. Bohra said that there is difficulty in implementing the regulation in 11kV feeders as there is breaker problem and procurement action is in progress and suggested to control the load from the grid S/S of OPTCL. CEO NESCO expressed that after installation of UFRS there is 13 tripping in 24 hrs causing chaos in the area, which may be stopped.

- CEO, CESU informed that infrastructure for power regulation has already been in place at IDCOL House i.e. control room, software requirement, feeder grouping, UFR installation etc. under intimation to OERC He expressed concern about the frequent tripping of breakers due to UFRs.
- CMD told the meeting that OERC may be moved to address the problem of frequent tripping of feeders due to installation of UFRs.
- Secretary, Energy DoE focused the need of power regulation management in a disciplined and co-ordinated manner so that essential supplies like railways,
   water supply and hospitals do not suffer. Secretary also pointed out that restriction made by OERC in case of HT/EHT consumers as 25% and 15% of their CDs seems liberal and OERC may be approached to make the regulation more realistic. He emphasized the requirement of stable power supply during Assembly session schedule to be held from 8th to 17th March'10.
- CMD GRIDCO deliberated in detail on the order of OERC para-wise and enquired from CEOs the progress made thereof.
- DISCOMs are of the opinion that as per para 23 (4), (5) & (6) the industries may opt for RTC power by paying 10P/U more which is not practical as all of them will opt for the same as a result there will be no regulation. It was opined that instead of 10 P/U it may be at least 400 P/U subject to availability of power. Industries having dedicated feeders may be advised to opt for procurement through open access from other states for which GRIDCO/OPTCLSLDC will cooperate in every respect. DISCOMs are also of the view that the assessment of OERC is not realistic which Hon'ble Commission may review.
- DISCOMs expressed concern about the shifting of demand from one period to other, as the load shedding hours is known to public through media reports, which should not be disclosed in detail.
- CMD asked DISCOMs have to bill the industries as per OERC Order and may meet their representatives on staggering of loads and weekdays holidays. DISCOMs may move to OERC to modify the order in respect of industries.
- CMD instructed SLDC to state the reasons while sending revised schedules to DISCOMs.

- DISCOMs told that data published in the website of SLDC is erratic which may be taken care of. They may be provided with Grid sub-station wise consumption data for better load management. It was advised that SLDC may be contacted for getting the actual figure if found spurious.
- DISCOMs representatives told that GoO may issue order for closing of shops & shopping malls etc. after 08:30PM.
- CMD advised DISCOMs to educate consumers for use of energy efficient & CFL lamps & bachat lamp etc scheme..
- Sr. GM SLDC explained the present power scenario of the state and said power availability from different sources is about 2050MW/49.20MU and demand is about 2200MW/52.08MU on average and 3000MW at peak load hours. There is a shortage of around 200MW on RTC basis and 550MW & 950MW at morning and evening peak hours respectively. It was opined that demand-availability has dynamic relationship. Shifting of demand by the consumers has menacing effect on power regulation. CESU informed the meeting that industry accounts 40% of their total load, whereas Wesco & Nesco informed that they have 70% & 49% respectively and Southco has 40%.
- Director (F&CA) in his briefing in the meeting said that during FY 2009-10 OERC has approved procurement price form all sources as 148 P/U whereas bulk supply price is determined at 122P/U. So there is gap of 26 P/U. But due to increase in FPA the procurement cost has gone-up and there is a gap of around 75 P/U between purchase and sale price. Another revealing factor in the ARR is that OERC has left a gap of Rs.638 crores to be bridged by export earnings which is not possible at the moment. GRIDCO has incurred a loan of Rs.900 crores till now and expected to incur another Rs.300 crores during this fiscal for which Govt. guarantee is proposed. GRIDCO is unable to pay the bills raised by generators. Govt. has been requested for subsidy,

## **IMPLEMENTAION OF INTRA-ABT:**

CGM (O&M) informed that mock exercise conducted by SLDC a few months ago has been concluded. In the above exercise Southco found to be mostly complying with the directions of SLDC and other DISCOMs have higher deviations. CESU has the highest deviation.

- CGM O&M informed that all Apex meters would be converted to 15 min DIP within 15<sup>th</sup> March. Data format of 15 DIP would be available from M/s Secure Meters by 1<sup>st</sup> week of March'10. And for UI calculation software has to be in place either by ERP vendor or by any agency. But as UI account is settled on weekly basis so collection of data from interconnection points on weekly basis.
- DISCOMs (except CESU) informed that their ABT cell has to be equipped with required software, hardware, manpower & communication facilities for which invest requirement is to be approved by OERC and they will move to the Hon'ble Commission accordingly.

## RECORD NOTES OF DISCUSSION ON 18.02.10 IN THE CONFERENCE HALL BETWEEN GRIDCO, OPTCL, SLDC AND DISCOMS REGARDING POWER REGULATION IN THE STATE AS PER OERC ORDER dt.14.01.10

Members Present: As per the list enclosed as Annexure.

The above meeting was convened to review the implementation of power regulation in the state in accordance with the OERC Order dated 14.01.10 in Case no. 01/2010 and the follow up action taken in this regard to be communicated to Hon'ble Commission vide letter dated 28.01.10 on daily basis.

Initiating the discussion Director (Commercial) explained the circumstances under which the power regulation in the state was imposed and stressed the need to implement the same effectively as per the OERC Order and not to be biased by the media report.

Director (Commercial) outlined some of the major points of the Order relating to Dos of the DISCOMs i.e. (i) DISCOMs should remain in the schedule confirmed by SLDC, (ii) segregating 11kV feeders in 5 groups for equitable restriction, (iii) implementation of UFRs in 132/33/11kV feeders at different frequencies, (iv) load regulation to HT & EHT industries to 25% and 15% of their CDs respectively. He told that Govt. has been appraised of the situation. He then asked SLDC representative to explain their problem in implementing the order.

SLDC representative informed the members present in the meeting the over drawal at 10:00hrs to-day by DISCOMs as per the following:

The above incursion is very regular by the DISCOMs. The ABT cells of the respective DISCOMs are not responsive. SLDC is serving in-numerable notices to DISCOMs. SLDC representative explained the modality of allocation of schedules (CESU=31.94%, NESCO= 22.67%, SOUTHCO= 11.43% WESCO=33.97%) to DISCOMs apportioning them as per the OERC approval in the ARR of FY 2009-10. The mock exercise for intra-ABT implementation has been completed. But there is lot of deviation from the schedule. In fact the drawals by DISCOMs are found to be more than the approval of OERC figure (apportioned up to Jan'10) excepting WESCO.

CGM(O&M) informed the members that the list of UFRs to be installed has been categorized by DISCOMs (except WESCO). The release of UFRs has been done and installation started in CESU. Installation of UFRs in NESCO is in progress. WESCO has confirmed to submit necessary information by 19.02.10. He advised NESCO to revise the category of feeders for equitable restriction of power, as they have submitted only 3 nos of feeders as non-priority feeders with frequencies 49.5Hz frequency. He also suggested we may move to OERC for revision of frequency band to 49.4, 49.5 & 49.6 as against 49.2, 49.4 & 49.5 as the normal frequency hardly reach 49.2HZ. However it is subject to observation of the effects with installation of graded frequencies of 49.5, 49.4

Shim combate

& 49.2Hz. He instructed DISCOMs to furnish the list of industrial consumers those who have opted RTC power by paying more and does not want to come under regulation and also a list of HT & EHT consumers those who opted for power regulation. He suggested DISCOMs to intimate where they need the help of OPTCL for power regulation at 132/33kV level.

CESU representatives told power regulation has not been implemented - effectively due to conflicting media reports. However, CESU is taking steps to implement the order after receipt of the letter from Director(Commercial). As CGM (O&M) told that in CESU area 50% of the feeders have been installed with UFRs as per the list submitted by them. CESU was requested to go by the orders of OERC and instructions

NESCO representatives described that over drawal and power regulation cannot be taken simultaneously. Due to increase in industrial load their forecast submitted to OERC in the last two years did not happen. HT/EHT loads constitute 35% of total demand out of which 70% of revenue is earned from EHT consumers. Even if they draw more from the Grid they are paying extra revenue to GRIDCO. From calculation it was established that their schedule being 420MW and actual demand is 520MW so there is a growth of 25% in HT/EHT load recently and they are regulating up to 6% of their demand, which is not very effective.

SOUTHCO representative expressed that power available from Machhkund is being utilized at Jayanagar, Rayagada, Tentulikhunti and Sunabeda areas where regulation of power could not be implemented. The power from Machhkund may be extended to Digapahandi and Berhampur for regulation purpose. He further pointed out about the ambiguity of HT/EHT consumers to give options to remain in power regulation regime or to avail power at higher price is yet to be decided by them.

Director (Commercial) said OERC has divided the quantum of energy for each DISCOM. It is observed that DISCOMs, excepting WESCO are consuming more than their entitlements leave about reducing the consumption.

It was also advised to extend power supply of Machhkund to further down stream areas and effect load regulation.

Sr.G.M(PP) expressed concern that voltage may be very less at the consumers' end if power from Machhkund will be extended to other areas like Berhampur & Digapahandi. Moreover Machhkund drawal is only 35 to 36 MW.

WESCO representatives expressed that mostly EHT consumers have their CGPs and drawing less power from the Grid. For 33/11kV industrial feeders notice have been issued to them to give options either to avail RTC power or to remain in the regulation regime. He also expressed concern that in share feeders, installation of UFRs at Grid S/S may not be possible due to varying options.

At the end Director (Commecial) summerised the issue relating to power regulation in the state and explained the following:

- OERC order on load regulation to be implemented;
- DISCOMs are entitled for power regulation in their respective areas of operation;
- DISCOMs to submit follow up action to OERC/GRIDCO/OPTCL
- DISCOMs to furnish list of 33/11kV feeders for installation of UFRs

- No power cut at night keeping in view of the 10<sup>th</sup> and 12<sup>th</sup> standard examinations as far as practicable. Power supply during evening hours may not be regulated. SLDC is to maximize hydel generation during such hours. This is also the instruction of the Govt. Regulation during day hours should be implemented to ensure availability and demand is matched;
- The compliance of the orders on regulation by OERC should be intimated to OERC and all concerned regularly.
